1. In pursuant to the tender announcement via Kuensel issue dated: **1st October 2024**, you are invited to submit your priced bid for the following:

2. The bidder(s) may quote for any or all items under this invitation. Each item shall be evaluated and contract awarded to the firm(s) offering the lowest evaluated price for each item.
3. The quoted price shall include all taxes, duties, insurance and any other costs involved and nothing extra shall be paid.
4. The bidder(s) shall submit one original of the priced quotation with the Form of Bid and clearly marked ORIGINAL. In addition, the bidder(s) should also submit one copy marked as COPY. The quotation including all documents in the attached format should be sealed in an envelope as required and addressed to and delivered at the following address [**Managing Director, Bhutan Trust Fund for Environmental Conservation**].
5. The deadline for receipt of quotation(s) by the purchaser at the indicated address is **14th October 2024 by 11.00 AM** and will be opened on the same day at **02:00 PM**
6. The bid shall be accompanied by a bid security of **2% of the Bids amount (two percent) only** in the form of cash warrant, demand draft or unconditional Bank Guarantee valid at lest for **2 months**, from the date of submission to the **Managing Director, BTF. Any bid not accompanied by bid security shall be treated as non-responsive and will not be considered for further**
7. Quotation by fax or by any other electronic means **will not** be accepted.



8. The quotation should be submitted as per the following instructions and in accordance with the attached Contract. The attached Terms and Conditions of the Work is an integral part of the Contract.
- a) **PRICE:** all prices shall be quoted in Ngultrum. The quoted price shall be inclusive of all related costs including taxes, duties and other levies to the final place of delivery. The final place of delivery is **Bhutan Trust Fund for Environmental Conservation, Near Nazhoen Pelri Complex, Thimphu;**
 - b) **EVALUATION OF QUOTATION:** offers determined to be substantially responsive to the technical specifications which will be evaluated by comparison of their quoted prices. In evaluating the quotations, the purchaser will determine for each quotation and evaluated price by adjusting the price quotation by making any correction for any arithmetical errors as follows;
 - (i) Where there is a discrepancy between amounts in figures and in words, the amount in words will govern;
 - (ii) Where there is discrepancy between the unit rate and the line item total resulting from multiplying the unit rate by the quantity, the unit rate as quoted shall govern unless in the opinion of the Employer there is an obviously gross misplacement of the decimal point in the unit rate, in which case the line items total as quoted shall govern, and the unit rate shall be corrected.
 - (iii) If the supplier refuses to accept the correction, the quotation will be rejected and the bid security shall be forfeited.
 - c) **AWARD OF PURCHASE ORDER:** the award will be made to the bidder who is offering the lowest evaluated price that meets the specifications. The successful bidder will sign a purchase order as per attached form and terms and conditions of supply.
 - d) **VALIDITY OF THE OFFERS:** your quotation(s) shall be valid for period of **60 days (2 months)** from the deadline for receipt of quotation(s).

Terms and Conditions for the Supply of Goods and Payment.

The Terms and Conditions hereinafter may only be varied with the written agreement of the Purchaser and no terms and conditions put forward at any time by the Supplier shall form any part of the Contract.

1. The Supplier shall be required to submit a performance security of 10% of the quoted price in the form of cash warrant, demand draft or unconditional Bank Guarantee issued by a financial institution located in Bhutan, which shall be furnished upon signing the contract. Performance security shall be valid till the end of warranty period and will be returned after the end of warranty period.
1. The supply of the goods shall be completed within **30** days from the date of issue of the Purchase Order, or the signing of the contract (if applicable); failing which, the supplier shall pay liquidated damages at the rate of 0.1% of the total cost per day.
2. Payment of the Invoice shall be arranged by the Purchaser, within thirty (30) days upon submission of original Invoice and TPN number, against the actual supplied quantities of goods as listed in the Purchase Order.
3. BTF is a tax-exempt organisation. Therefore, the supplier shall submit original tax (Customs Duty/ Exercise Duty/ Sales Tax etc.) payment invoice/bill for necessary record and follow-up actions.
4. Any goods found defective during the warranty period shall be replaced/repaired by the supplier at his cost. If the supplier fails to rectify and or replace the defective goods, the purchaser shall do it at the cost of the supplier.
5. The Supplier shall promptly notify the Purchaser in writing of the delay of delivery of Goods, its likely duration and its cause. The Purchaser on evaluation of the situation may extend the extension, at its discretion.
6. The Purchaser may, by written notice, terminate the Purchase Order (or Contract if applicable) in whole or in part at any time for its convenience:
 - a. if the Supplier fails to perform any other Terms and conditions specified with the Purchase Order, or exceeds the maximum amount of liquidated damages.
 - b. if the Supplier fails to perform any other obligation(s) under the Purchase Order, or
 - c. if the Supplier does not take any remedial action within a period of (7) seven calendar days after receipt of a notice of default from the Purchaser specifying the nature of the default(s), or
 - d. if the Supplier, in the judgment of the Purchaser, has engaged in any corrupt or fraudulent practices in competing for or in executing the tasks under this Purchase Order; and
